Letters-of-Access (LoAs) for referral and Licenses-to-Use (LtUs) for incorporation of data in another Registration dossier are available for granting through specific agreements.
<b>“OR” and “importers” in consortium/a</b>	EU-based legal entities are ORs for some multi-national consortia members. Non-EU manufacturers/importers have appointed a consultancy company based in the EU as OR.
<b>Technical work</b>	General secretariat and technical work have been contractually mandated to the IZA-team. The work programs and budgets are presented, reviewed, and agreed at the yearly Steering Committee (SC).
